Any animal experiment performed in Denmark including Aarhus University must comply with the EU Directive on the protection of animals used for scientific purposes (63/2010, entry into force by 01.01.2013^{1, 2}) as well as national legislation³⁻⁸ and Institutional regulations, including the Animal Welfare Policy at Aarhus University⁹.

Any animal experiment, *i.e.* any procedure that exceeds the needle criterion, performed at a Danish research institution requires a permit from the Danish Animal Experiments Inspectorate (DAEI) as the competent authority. Thus individual universities have no jurisdiction to issue permits, but have the responsibility to ensure that all activities involving experimental animals comply with national laws and rules. Aarhus University fulfills this requirement through a local university committee that oversees animal research and the housing facilities. As such this local committee is the equivalent of an IACUC, although permits can only be issued by the DAEI. The DAEI perform unannounced inspections at regular basis to ensure that housing facilities and experimental procedures comply with the regulations and the particular license. References to the regulations and policy are listed below.

The DAEI is the competent authority appointed by the Ministry of Environment and Food of Denmark, which is chaired by a judge, and has representation from major stake holders, such as research councils, industry and animal welfare groups. As stated by European laws for animal's experiments, all researchers applying for a license for a particular experiment must have a FELASA C course or equivalent.
